## Reminders and Announcements

#### **Taxes**

Reminder! Taxes are DUE October 28th, 2022. Interest charges will be applied at 1.25% for any outstanding balance after the due date. Payments can be made at the office by cash, cheque, or debit. You can also pay through online banking with most financial institutions.

Supplementary Taxes will be mailed at the beginning of September and are DUE December 31st, 2022. Interest will be applied January 1st, 2023, for any outstanding balance.

#### **Municipal Right of Ways**

Municipal Right of Way – means lands owned by the Municipality of WestLake-Gladstone as opened or unopened road allowances, or for the purposes of operating a public highway under the Municipal Act, a public walkway, municipal services, or public utilities. If you are farming this area, please be aware that the Municipality can enter these right of way lands and perform works in that area at any given time. If you plant your crop on Municipal lands, there is a chance that it may be dug up or driven though for all kinds of reasons as we continue to survey ditches throughout the municipality.

#### **Municipal Elections 2022**

Municipal elections are on Wednesday October 26, 2022, for the Municipality of WestLake-Gladstone at large. If you are interested in Municipal Government, learning more about your municipality, interested in financial planning, services, policies and programs, and being part of a team to execute all these then keep reading on how to run for Council.

As a council member, you are part of a team that will contribute to the development of the above noted items and more to ensure services are delivered to your ratepayers and residents.

Head of Council/Council member's term lasts for 4 years, and you will have to commit and dedicate time to your duties, council meetings, and to the ratepayers and residents' questions and concerns.

#### **Qualifications for candidates are as follows:**

- Canadian Citizen
- 18 years or older
- Resident of Manitoba
- Voter in the Municipality own property or reside in the municipality for 6 months prior to Election day (April 26, 2022)
- An employee of the municipality if a leave of absence has been granted

Registration for the Head of Council begins on May 1, 2022, and Councillors start June 30, 2022. Please call the Municipal office for the SEO on registration, forms required and any other questions.

Nomination period will be in September and at that time you may come forward and get a nomination form. Nomination forms must have 25 eligible voter's names on it and nomination period will cease on September 20, 2022.

## **Board of Revision**

#### **Public Notice: Board of Revision**

Public notice is hereby given that the 2023 Assessment Roll for the Municipality of WestLake-Gladstone will be delivered to the Municipal Office at 14 Dennis Street E, Gladstone, Manitoba, on or before September 2nd, 2022, and will be open for public inspection during regular business hours. Applications for revision may be in accordance with sections 42 and 43 of the Assessment Act:

#### APPLICATION FOR REVISON:

42(1) A person whose name property has been assessed, a mortgage in possession of property under section 114(1) of The Real Property Act, an occupier of premises who is required under the terms of a lease to pay the taxes on the property, the authorized agent of the person, mortgagee or occupier, or the assessor may make application (*fillable form on www.westlake-gladstone.ca*) (Click on Municipal\Tax Information\Board of Revision) for the revision assessment roll with respect to:

- A) Liability to taxation;
- B) Amount of an assessed value;
- C) Classification of property; or
- D) A refusal by an assessor to amend the assessment roll under subsection 13(2)

#### **APPLICATION REQUIREMENTS:**

43(1) An application for revision must

- A) Be made in writing (visit www.westlake-gladstone.ca for fillable form)
- B) Set out the roll number and legal description of the assessable property for which a revision is sought;
- C) Set out which of the matters referred to in subsection 42(1) are at issue, and the grounds for each of those matters; and
- D) Be filed by
  - (i) Delivering it or causing it to be delivered to the office indicated above, or
  - (ii)Serving it upon the secretary, at least 15 days before the scheduled sitting date of the board as indicated in the public notice

Applications sent electronically must confirm appeal received by municipal office.

#### **FEES**

A minimum filing fee of \$50.00 must accompany your application form (on website) with an additional fee of \$10.00 for each \$50,000 of assessed value of the property to a maximum of \$300. The filing fee is refundable in the case where an appeal is reached prior to the Board of Revision sitting. The filing fees are non-refundable if a decision cannot be made at the Council level and the property owner chooses to file an appeal to the Municipal Board.

The Board of Revision will sit at the WestLake-Gladstone Municipal Office on October 19<sup>th</sup>, 2022, at 9:00 a.m. to hear applications. The final date on which applications must be received by the Secretary of the Board is October 3rd, 2022, between regular office hours Tuesday - Friday (8:30 am- 4:30 pm).

Prior to filing a complaint against the liability to taxation, amount of an assessed value, or classification of property, you are encouraged to discuss the matter with the Provincial Municipal Assessment Branch; phone 204-239-3320.

## Communication Corner

#### **Burn Ban & Burning Permits**

Burn permits are MANDATORY for all open-air burnings and for fireworks. This is required to notify the fire department of any potential fire hazards in the Municipality. When a fire ban is implemented burn permits will not be available and information will be released through our Website and Connect. Failure to comply with a burn ban can result in fines up to \$2,000. Burning permits are not required for campfires as long as they are contained in a fire pit.

#### **E-Billing - Go Green and Help Conserve the Environment**

To receive your water bill by email please send an email to info@westlake-gladstone.ca with your name, civic address, and account number.

We now accept e-Transfer for payment of Utility Bills! To ensure your e-Transfer payment is receipted to the correct account you MUST include your account number in the "note" section. We also offer Preauthorized debit. Please contact the office to sign up.

If you are purchasing or renting a property, please remember to contact the office to set-up or move your account. If you are selling your property, please call and request a final bill.

#### **Responsible Pet Owners**

The Municipality receives several complaints about animals defecating (pooping) on properties, both public and private. These complaints are for horses, dogs, cats, etc. We kindly encourage you to please clean up after your pet on all properties, pathways, sidewalks, streets, lanes, etc. All dogs must be on a leash!

#### **Street Sense - Slow Down!**

A friendly reminder to motorists to please pay attention to the crosswalks during warmer weather because people are outside walking, jogging, and biking.

Just a reminder also that bicycles are NOT permitted on sidewalks.

## Communication Corner Cont.

#### **NEW AND UPDATED BY-LAWS**

The following By-Laws have been passed and are in effect:

- 1. <u>Unsightly Property</u> being a by-law to provide for the maintenance of property and the regulation and abatement of nuisances and unsightly property within the limits of the Municipality of Westlake-Gladstone.
- 2. General Enforcement being a by-law to provide for general enforcement by the Municipality of its by-laws, provisions of *The Municipal Act*, *The Planning Act*, and any other Act the Municipality is authorized to enforce, and any permits, authorizations or agreements issued by or entered into by the Municipality under the authority of such Act, by-laws, or provisions.

Public Hearing prior to implementation:

1. <u>Derelict & Vacant Buildings</u> – being a by-law to establish a system to regulate the condition and maintenance of vacant residential and commercial buildings and to establish a process to take title to vacant and derelict buildings. Public Hearing is set for August 3, 2022 at Stride Hall in Gladstone at 10:00 a.m.

The Municipality has entered into a contract with Prairie By-Law Enforcement for their services. The Municipality shall operate on a reactive complaint-based process regarding municipal law enforcement except for a violation that is an immediate threat to health or safety.

Complaint means a complaint received by the Municipality, wherein the <u>complainant</u> provides their full name, address, phone number and nature of complaint that can be verified by the Municipal By-law Enforcement Officer, in writing using the required form submitted to the Municipality. Complainants' information will not be share and all information provided will remain confidential.

#### **CYBER FRAUD UPDATE**

#### **NEWS RELEASE #3**

July 11, 2022

DD West LLP, legal counsel for the Municipality, is providing an update to the residents of the Municipality on the cyber security breach which occurred and resulted in access to Municipal funds held in Stride Credit Union. Following this incident, the Municipality immediately engaged legal counsel, information technology services experts, and cybersecurity experts to assist in investigating the incident and recovering funds.

Litigation processes have been commenced against Stride Credit Union relating to its computer system and the loss of funds, and against Western Financial and Traveller's Insurance relating to the insurance policies and denial of claims under those policies as they related to cyber insurance. These lawsuits are in the document discovery stage and will be proceeding to examinations for discovery once all documents have been exchanged. The collection of electronic data and e-discovery creates a much longer timeline because of the format of information being requested.

The Municipal Auditors are aware of the incident and have commented on them in their report. They have noted that to balance the financials for the year surplus funds were available.

We can advise the residents and ratepayers of WestLake-Gladstone that there is **NO** evidence the Chief Administrative Officer took or misappropriated the funds or was involved in any manner whatsoever with respect to the taking of the funds. In addition, given the very short time over which the money was removed from the account the Chief Administrative Officer handled the matters appropriately and followed office procedures and proper banking service reviews. We remind all individuals to refrain from any slanderous or libel allegations and request everyone refrain from making unacceptable remarks about or towards the CAO. Cyber crime is rampant and unfortunately, the Municipality and Stride Credit Union have been victims of it.

The legal team wants to thank you for your patience as we navigate through the litigation process and investigation of the facts surrounding the cyber security breach, in which significant money was electronically stolen from the Municipality's operating bank account.

Council & CAO are working with the legal team and is committed to providing updates when provided. Once again thank you for your patience as we continue to recover the money for the Municipality.

# Building, Development & Fire

#### What is a building permit?

A building permit is a document that provides legal authorization to begin construction of any type of building or structure.

#### Why is a Building Permit Required?

A building permit is required to protect the health and safety of the public. After the application is filed, the CAO and Building Inspector review the project design before construction begins to ensure compliance with Building Codes and Zoning By-Law regulations. A Development Permit is required for any change in land use or site development.

#### **Permits Required:**

- Finishing unfinished spaces in a home (basement, attics, etc.)
- Repairing of foundations
- **↓** Installation of Wood Stoves or Fireplaces
- ♣ Installation of pools holding over 24 in. water
- ♣ Enclosure of an existing open deck
- Construction of attached or detached garage or carport
- Demolition, removal or partial removal of buildings or structures
- Construction of a detached accessory building

#### **Permits Not Required:**

- **♣** Replacement of stucco, siding, or shingles
- ♣ Replacement of doors when the opening is not enlarged or reduced in size
- ♣ Replacement of an open landing and stairs
- Construction of Fences
- Patching, painting, decorating
- **↓** Installation of cabinets and shelves

During busy building seasons, permits can take up to 4 weeks for processing.

#### **Demolition Permit**

To have buildings you have demolition removed from your taxes. Please complete a demolition permit.

#### **Grain Bins**

Grains Bins are considered an accessory use to the primary use of your property. All grain bins require a \$45 Development Permit to ensure proper setbacks are met. Failure to apply for the permit will result in fines and increase in permits fees.

### **Swimming Pool and Hot Tub Requirements**

Swimming pools, hot tubs, and similar structures with a water depth of greater than 0.6 meters (2 feet) must be protected by a fence with lockable gates and minimum height of 1.8 meters (6 feet) to prevent unauthorized entry. The fence and gate must be constructed as to prevent a child from crawling underneath. A Development Permit is required. Failure to place a pool or hot tub prior to the proper permits and fencing will result in fines and increase permits fees.

#### **Tipping Fees - All Waste Disposal Grounds**

Public Tipping Fees - \$10.00 per item

Tipping fees are applicable, but not inclusive to the following Items:

Water softeners, hot water tanks, dishwashers, stoves, fridges, washers, dryers, freezers, air conditioners, couches, chairs, tables, mattresses, and box springs.

Commercial Tipping Fees- \$20 per Half Ton / \$40 per Single Ton / \$114 per Single Axle 3 Ton \$385 per Tandem Axel 7.5 Ton / \$523 per Semi-Truck 14 Ton

Please report illegal dumping!

#### **Garbage and Recycling MWM**

Reminder, please have your carts out for 7:00am. Make sure that the wheels are against the curb, or along the grass line if no curb is available. Have the front of the cart towards the road. Leave an arms length of space between the cart and any other object. Don't place the cart under an overhead obstruction. Only waste **INSIDE** the cart will be collected.

All recyclables in one cart means no sorting or bagging: place all material loose in the cart except for, shredded paper, newspapers, flyers, inserts, & junk mail - please bag those items in a clear or blue bag & tie it. Please be aware the glass food and beverage containers are also to be placed in the bins. Medical Assist Program is available for those needing assistance in getting their cart to the curb.

The Municipality would like to address the following statement in the previous newsletter regarding the waste and recycling bins.

"If your bins are not full, please wait until they are full before putting them out to be collected."

When the Municipality published the newsletter, it was of the intent that there are some who put their carts out with just a few milks jugs/ cart less than ¼ full and since the Municipality is being charged per tip, it would be more cost efficient and resourceful if the carts (recycling in particular) were only put out when reasonably full. MWM donates \$0.05 per recycling cart tipped to a charitable organization within our community. That being said, the benefit of the \$0.05 per recycling tip outweighs the cost to the Municipality since the costs were calculated based on bi-weekly tipping and all costs are being re-cooperated through the special service levy. The levy was calculated using the total cost of MWM's services, less the recycling revenue the Municipality receives (approx. \$15,000 to \$20,000 per year depending on recycling volume) divided by the number of properties receiving the service.

We apologize as this has caused some confusion and we thank those that have brought this to our attention. We encourage all residents to recycle, it not only benefits the environment, but also your community!

- **Paint** (Household paint and all paint aerosols).
- **Lights** (Fluorescent tubes and CFLs).

Household Hazardous Waste (Flammables, corrosives, toxics, and pesticides).

For safety reasons, all products brought to the event MUST be in their original container with original label(s) intact into be accepted by the program. Containers that have no label, are leaking, or are improperly sealed will not be intacted accepted.

#### **Accepted Products:**

- Pesticides: We accept liquid, solid and aerosol pesticides. The maximum container size is 10 litres.
  The maximum aerosol container size is 680g / 24oz. To be accepted, the product label <u>must</u> have:
  - ➡ The poison symbol (skull & crossbones)
  - ♣ The Pest Control Product (PCP) number
  - **♣** The word 'domestic'
- Toxics: We accept liquid and aerosol products. The product label must show the poison symbol (skull and literossbones) and the word 'danger'. Examples: Automotive additives, furniture stripper, lubricants, and tar and bug remover. The maximum container size is 10 litres. The maximum aerosol container size is 680g | 1/240z.

<u>Corrosives</u>: We accept liquid, solid and aerosol corrosives. The container label must display the corrosive symbol. Examples: Grout cleaner, Masonry cleaner, Pool and hot tub cleaners, or rust remover. The maximum container size is **10 litres**. The maximum aerosol container size is **680g / 24oz**.

Flammable Liquids (including gasoline): We accept liquid and aerosol flammables. The container label must display the flammable symbol. Gasoline will be accepted only in a ULC-approved gas can or jerry can. For safety reasons, the gasoline container cannot be returned to you at drop off. The maximum container size is 10 litres (25 litres for gasoline only). The maximum aerosol container size is 680g / 24oz.

Physically Hazardous Products: We accept products with a label displays both the flammable symbol and explosive symbol. Examples include non-refillable fuel cylinders such as: non-refillable butane cylinders, non-refillable camping cylinders, or non-refillable propane cylinders. Maximum container size is 5kg and containers must not be refillable.

#### SUMMER DAY CAMP – LACK OF ATTENDANCE

#### **Program in Jeopardy**

The Municipality has been offering the summer day camp program for several years in Langruth, Plumas, Westbourne, and Gladstone. Due to no interest in Langruth and Westbourne this year the program is not being offered in these communities. Gladstone and Plumas are currently experiencing extremely low attendance. Staff have organized themed activities for the day camp program and this year have added Field Trips to the agenda. Unfortunately, due to the lack of interest and low attendance we will be forced to eliminate this program as soon as this August. For the program to run we need a minimum of 10 children per day.

The Municipality has advertised this program extensively. Connect notifications have been sent, posters have been created and posted in all communities, and updates have been posted to the municipal website as well.

## STOP AQUATIC INVASIVE SPECIES

Aquatic invasive species (AIS) pose a serious threat to aquatic ecosystems and water bodies. These invaders can have long-lasting, negative economic, environmental, and social impacts.

Species such as zebra mussels, spiny water flea and rusty crayfish are spread by people, which means people can prevent their spread.

YOU can help by following these actions - no special equipment necessary!

#### Before leaving a water body:

- Clean by removing aquatic plants (i.e., weeds), debris, mud, and animals from watercraft and
- gear. These items can either harbour invasive species or be prohibited AIS themselves.
- Drain all water and keep drain plugs open/out during transport.
- Dry gear completely before placing into another water body.

#### Additionally:

- Never release bait, plants, or aquarium pets into Manitoba's water bodies.
- Decontamination may be required to ensure watercraft, gear etc. are AIS free before placing items into another water body.

The open-water season and winter (ice-covered) season checklists are helpful step-by-step resources that can help you comply with the Manitoba government's AIS Regulation.

## WestLake-Gladstone Secures Funds for New Swimming Pool

A new \$1.25 million outdoor recreation venue will soon begin construction in Gladstone. Western Recreation has been retained to construct a new outdoor heated swimming pool and Ellwood McRorie has been awarded the construction of a new pool house. These new facilities will replace the existing 50+ year old facility that is beyond its useful life and on the verge of being closed permanently.

The new facility will include a walk-in entry for beginners, a lazy river, diving board, mushroom spray unit and a water slide (if funds allow). The new facility will continue to offer all of the same programs that the existing pool offers such as swimming lessons for all ages and private rentals.

Construction is set to begin August 2022 and if all goes according to plan, the new facility will open as early as June 2023. WestLake-Gladstone council recognizes that swimming is not a hobby, but a life skill and they are very honored to continue to offer this opportunity to residents and visitors of all ages.

This project was a goal of the elected council of 2018, and the administrative team has worked diligently in applying for grants and investments for this new facility and that is why we are at the construction stage only three years later. On June 10, 2022 Mayor Scott Kinley and CAO Coralie Smith were invited to The Forks in Winnipeg to participate in the announcement and release of \$10.8 million from Prairies Economic Development Canada (PrairiesCan). This announcement was in support of Manitoba's travel, tourism, and recreation providers recovery from the impact of Covid-19. WestLake-Gladstone will receive \$425,000 from this investment, which was announced by Terry Duguid, Parliamentary Secretary to the Minister of Environment and Climate Change on behalf of The Honourable Daniel Vandal Minister Responsible for PrairiesCan.

WestLake-Gladstone was also successful in securing funds through the Province of Manitoba <u>Building</u> <u>Sustainable Communities</u> in the amount of \$300,000. BSC fosters thriving sustainable communities and partners with other funders to leverage investments to provide a high-quality life for Manitobans. The capital infrastructure supports recreation development, as well as projects that extend, improve of enhance existing public use community facilities and spaces.
